## **VACANCY ANNOUNCEMENT - # 09-067**

### **OPEN TO: All Eligible Family Members (EFM), who are:**

- 1) Listed on the travel orders of a Foreign or Civil Service or uniformed service member permanently assigned to or stationed at a US Foreign Service post or establishment abroad with a USG agency that is under COM authority;
- 2) Is resident at the sponsoring employee's or uniform service member's post of assignment abroad, approved safehaven abroad, or alternate safehaven abroad;

### **MAJOR DUTIES AND RESPONSIBILITIES:**

Duties, tailored to experience/grade, will include the following: Serves as personal secretary to the Defense, Army, Navy and Marine Attachés. Also acts as manager of DAO 4<sup>th</sup> floor office suite responsible for control / preparation of administrative requirements and suspense files under OPSCO supervision. Receives and screens all visitors and telephone calls, monitors phone bill expenditures, prepares travel orders, maintains electronic calendars, schedules appointments, makes necessary travel, hotel and vehicle reservations for principal attachés. Prepares correspondence for signature by the Defense Attaché and other personnel, as required. Lends additional administrative support to other attachés and staff when time permits or as needed. Assists in the preparation and execution of DAO representational responsibilities as directed. Manages the representational gift program for all four services. Establishes and maintains a variety of reports and files as required.

### **Minimum Qualifications:**

**NOTE:** All applicants must address each selection criterion detailed below with specific and comprehensive information supporting each item.

- Must be a U.S. citizen, either an Eligible Family Member or a resident with legal status / work permit in Israel.
- Must possess or be eligible to obtain a Top Secret clearance.
- Must have 1-to-2 years of administrative experience.
- Must be able to type 40 words-per-minute.
- Must have good organizational and interpersonal skills.

## **HOW TO APPLY:**

- Vacancy number must appear on all applications.
- Applications must be received by the closing date specified on the announcement. Applications received after this date will not be considered.
- Resumes must include: Citizenship, date of birth, fax number, or complete mail address, colleges attended, work experience (include dates of employment, duties, correct address for employer), special skills, language, trade and licenses.
- U.S. citizens must be 18 years of age or hold a high school diploma to be eligible for consideration.
- The application must contain all information necessary to demonstrate that the candidate possesses the education, experience, skills and language abilities required for this position. Applicants who fail to meet requirements for the position will not be considered.
- If college education is a requirement for the position, a transcript is required.
- Candidates are subject to testing for language, computer or other position related skills.

## **OTHER INFORMATION:**

- Former U.S. military members (up to rank of Major) who claim Veteran preference and are spouses of U.S. Diplomats posted in the U.S. Embassy in Tel Aviv, only may receive preference if found qualified for the position. Copy of DD-214 must be provided.

## **SELECTION CRITERIA:**

- Management will consider nepotism/conflict of interest, budget, and residency status in determining successful candidacy.
- Current employees serving a probationary period are not eligible to apply.
- Current employed US Citizen EFMs who hold a FMA appointment are ineligible to apply for advertised positions within the first 90 calendar days of their employment.
- Currently employed NORs hired under a Personal Services Agreement (PSA) are ineligible to apply for advertised positions within the first 90 calendar days of their employment, unless currently hired into a position with a When Actually Employed (WAE) work schedule.
- (As required): The candidate must be able to obtain and hold a security clearance.

## **DEFINITIONS:**

1. AEFM: A type of EFM that is eligible for direct hire employment on either a Family Member Appointment (FMA) or Temporary Appointment (TEMP) provided s/he meets all of the following criteria:
  - US citizen;
  - Spouse or dependent that is at least age 18;
  - Listed on the travel orders of a Foreign or Civil Service or uniformed service member permanently assigned to or stationed at a US Foreign Service post or establishment abroad with a USG agency that is under COM authority;
  - Is resident at the sponsoring employee's or uniform service member's post of assignment abroad, approved safehaven abroad, or alternate safehaven abroad; and
  - Does not receive \ USG annuity or pension based on a career in the US Civil, Foreign, or uniform services.
2. EFM: Family Members at least age 18 listed on the travel orders of a Foreign or Civil Service or uniformed service member permanently assigned to or stationed to a US Foreign Service post or establishment abroad with a USG agency that is under COM authority who do not meet the definition of AEFM above.
3. Member of Household: A MOH is a person who: 1) Has accompanied, but is not/not on the travel orders of a U.S. citizen Foreign or Civil Service employee or uniform service member permanently assigned to or stationed at a U.S. Foreign service post or establishment abroad; 2) Has been declared by the sponsoring employee to the Chief

of Mission as part of his/her household; and 3) Resides at post with the sponsoring employee.

4. Ordinarily Resident (OR): A citizen of the host country or a citizen of another country who has shifted the main residency focus to the host country and has the required work and/or residency permits for employment in country.
5. Not-Ordinarily Resident (NOR): Typically NORs are US Citizen EFMs and EFMs of FS, GS, and uniformed service members who are eligible for employment under an American USG pay plan, on the travel orders and under Chief of Mission authority, or other personnel having diplomatic privileges and immunities.
